# President's Report -

- Top community topics in Summer:
  - Homeless Encampments
    - The Board had a robust discussion about the ongoing issues surround the homeless encampments. Many Board members expressed frustration on the increasing number of encampments given DC's significant budget expenditures on homelessness. Moreover, the Board questioned whether the increasing number of homeless individuals are DC residents or from outside of Washington, DC. Many Board members worry that providing showers at the encampments, as discussed at the last ANC meeting, will encourage individuals to reject assistance. President George will contact various DC officials about the continuing homelessness encampments, asking for updates and accountability.
  - GWU Off-Campus Students
    - GWU has produced a brochure for students about DC services. FBA homeowners produced a more detailed brochure about these services, such as trash collection. Over Labor Day weekend, there were some calls about excessive noise to the police and GWU. FBA, homeowners, and GWU have a protocol for working through various issues before contacting DC officials. President George asked Joe Florio for information about the business license for the homes at issue including the number of people permitted to live in the house. Julia suggested looking at whether the owners who are renting out these homes are claiming the homestead exemption.
  - o GWU Sept 11, 2021 Day of Service
    - 10 GW students will come through the neighborhood to help with cleanup.
