- GWU Hospital Helipad Proposal Status
- Homelessness
  - ✓ Two people suing the city for not preserving their belongings, which city is required to do for 60 days; trying to make it a class action suit. City is not following its own policy, which is that they cannot throw stuff away if found on the street

- Clean Community
  - Jake at Boston Properties (new development at 2100 Pennsylvania) has agreed to provide these amenities, among others:
    - Add sidewalk at Penn and I Street (corner where Watching Post is)
    - o Contribute to a second entrance to Foggy Bottom Metro stop
    - o Put in water source at 26<sup>th</sup> Street Park
- Citizen's Association of Georgetown v. FAA (Airplane Noise)
  - ✓ No vote was taken regarding FBA making further financial contributions to this effort until we find out more about the potential of bargaining for FAA-approved sound-insulating windows for affected residents
